The Sequential Discipline Standard was developed for all schools within the Moreno Valley Unified School District and outlines the consequences for inappropriate student actions that have been referred to the Principal, Assistant Principal, or Dean of Students. It should be noted that although the Sequential Discipline Standard affords a framework for dealing with inappropriate student behavior in a comprehensive and consistent manner, each disciplinary issue will be reviewed within the context of its unique circumstances and the educational needs of the student. Each administrator must use his/her judgment in applying its provisions, within the limits stated. Situations not specifically addressed in this plan or unusual or extreme cases will be dealt with in accordance with District policy and the California Education Code 48900. Any exception to the consequences stated in the Sequential Discipline Standard will be documented by the school site. Some elementary schools may use On Campus Suspension (OCS) as an intervention consequence.
